#### I - Introduction: Who are we and what do we ask?

Tens of millions of Europeans, of all origins and sensibilities wishing to remain faithful to the values of Democracy, Human Rights and Progress, and who rejected a contradictory, ineffective and authoritarian Health policy.

Since the declaration of the covid 19 pandemic four years ago at the beginning of the year 2020, tens of millions of European citizens have refused experimental vaccines, as well as ineffective, deadly and ruinous health policies imposed by governments and international bodies working hand in hand with the most condemned pharmaceutical companies, in violation of Human Rights and European regulations concerning GMOs and the human person.

We are among these people who have been warning and denouncing the catastrophe of a health policy characterised by absurdity, authoritarianism and contradiction: scientists and doctors of the highest repute, former pharmaceutical industry executives, lawyers specialising in health, human rights activists, investigative journalists, teachers, writers, artists, citizens' groups and associations and a few politicians.

We are independent of political parties, origins or denominations, from all social classes and all walks of life, united by lucidity brought by independent information and experience, respect for rights or suffering, our own, that of our children, our elders and our loved ones.

Categorising, caricaturing or censoring tens of millions of citizens, who have been vindicated over the past few years, makes no sense, but once again amounts to validating and endorsing a policy that runs counter to the values and realities proclaimed. Imagining that, in 2020, the most honoured servants of medicine and populations were suddenly struck by madness while the most cynical lobbies were touched by grace and virtue is of course impossible to believe. We must therefore act.

Countless complaints, articles and scandals have been filed and published. The victims of adverse events, deaths and serious handicaps for the rest of their lives, listed by the most official bodies in the States, in Europe and elsewhere, number in their millions. You will find them at the point V of this call.

#### II - A key moment in History of Europe and the World

We are clearly at a key moment in the History of Europe and the World, and this is why we are launching this call to the founding values of Europe not to collaborate with private interests damaging our Humanity, in the dual sense of the word.

Because we are living a war against memory and against future, in the following declaration and charter, we will just remember you of what Europe and the World have experienced in recent years, and warn you of what is coming, in the image of other past events, following similar logics and interests, harming entire populations for many years to come.

You can contribute to the reversal of Europe's slide towards a dictatorship resulting in a moral, cultural, economic, existential and political disaster – there are enough parallels in Europe's History! We will support you all along!

Not only the Old World, but also the whole World, is looking more and more like a dystopia reconciliating the worst ideologies and mirages of the 20th century.

Strangely enough, one century before covid, the Spanish Influenza - the great influenza pandemic - preceded the rise of Fascism in the West.

Our era is undeniably the scene of a battle for memory and the future, waged between opposing camps, with the direction of our entire Western civilisation at stake for the next years. In this declaration and charter, we recall what Europe and the world have experienced, what is officially announced or clearly apparent in the decisions taken, evoking other past events that have followed similar logics and interests, compromising the future of entire populations, and we propose a certain number of means to avoid it.

You can help reverse Europe's slide towards a dictatorship that will lead to moral, cultural, economic, existential and political disaster - there are enough parallels in the history of the Old Continent - and of others - and of Globalisation. We will support you throughout the process, if you adhere to these values, this hope and this fight already underway.

It is those who have lived through our darkest hours who are the first to say it: Old Europe, but also the whole World, is looking more and more like a dystopia reconciling the worst ideologies and mirages of the twentieth century.

And a century before covid, the Spanish Flu had itself preceded the rise of fascism in the West. You know as well as we do the recurrent exploitation by authoritarian regimes of natural, financial or health crises.

For this reason, we ask you to read the Humanist, Ethical and Medical Charter for the forthcoming European Elections.

Our votes, we repeat, independent of ideologies and interests, represent millions of people around Europe, who themselves most of all represent, recall and demand the founding values of Europe and its civilisation, of all true civilisation: Humanism, Knowledge, Freedom, Common Good, Security, Transparency, the right of people to self-determination against private interests.

These are the values of Greek Antiquity, Christianity, the Renaissance, the Enlightenment, Progress

Whatever your political persuasion, the values expressed in this declaration are necessarily yours, just as the fight we are waging can only be yours.

In this historical moment, we call you for Dignity and Humanity.

We ask that your words, programmes and actions express this today, and our votes and our supports will follow, as will our vigilance.

The absence of a clear statement on the following facts and points, crucial for our future, the absence of a formal commitment on these specific issues would be tantamount, we repeat, to validating or accepting a policy mortgaging the future of Europe and the peoples whose servants and representatives you are.

There is no fate. There are just choices. United, everything is possible. We will be millions with you.

#### III- Europe since Spring 2020: a useless, catastrophic and authoritarian policy

#### Unjustified mortality prediction models leading to crazy policies.

At no time, since the Spring of 2020 have the mortality models of Neil Ferguson of Imperial College, who had already predicted the worst for H1N1, been approached or confirmed.

And yet, these announcements of millions of deaths and the manipulation of the PCR tests enabled the governments to impose and provoke the worst.

At the highest levels of the European Union, contracts with serious human and financial consequences were negotiated irregularly for billions of euros.

#### 2020: a turning point in History

The health crisis, as we all know, has served to mark a turning point in History: repeated confinements, suspension of freedoms, decrees, defence councils protected by state secrecy for fifty years, sudden bans on treatment and medicines that had existed for decades, censorship and suspensions of hundreds of thousands of doctors and carers, societal divisions, an explosion in psychological disorders among young people, excess mortality among the elderly and the sick due to the closure of hospital services and the lack of diagnosis, the disappearance of many self-employed workers, medicines shortages.

These are just some of the well known consequences of the decisions of a handful of heads of state advised by world-famous law firms also repeatedly condemned for harming whole populations and health systems.

## Democracy and the well-being of people have collapsed in favour of an unprecedented concentration of power and wealth.

The unelected European Commission is taking its orders from the World Health Organisation, itself financed by private funds from tax-evading foundations and chaired by an extremely controversial man who is the subject of several complaints for crimes against humanity in his home country following the violent repression of popular riots.

On the one hand, a dizzying impoverishment and precariousness of populations, and on the other, an exponential increase in the wealth of the GAFAMs and social networks deciding on censorship and scientific truths with those responsible for the chaos themselves.

A model more reminiscent each year of the great dictatorships with which the young political or cultural leaders of our "free world" maintain close commercial and collaborative relations.

For four years now, more than ever, Europe, its decision-makers, its partners and also the representatives of its people have been at odds with the founding principles of the Union after the Second World War: Peace, Democracy and Progress ensured by the market economy.

Technosciences: CAP, GMOs, CBDC, AI, mRNA vaccines, WHO, 5G: the measures furthest removed from ecology, freedom, health, democracy and the right of the people to self-determination presented as the only way to save a Humanity endangered by those who would impose them, privatisation of Life and the end of privacy.

After the human and ecological disaster of the Common Agricultural Policy, the health of entire populations is under threat, and the large-scale transfer of GMO technologies from the plant and

animal kingdoms to humans, starting with children, through covid vaccines and all those that will follow, since the summer of 2021, without reason or consultation, in violation of previous regulations, is no accident. This is techno-science without the precautionary principle, designed to serve the specific interests of its sponsors and having nothing to do with scientific progress in the service of the public, which is what it is supposed to be.

#### Pretending to save Humanity by the very ways that loose it.

Just as GMOs produced by former military firms or globalization of industrial and dangerous food have not solved and will never solve the problem of hunger in the world, experimental vaccines will not solve global health issues, the vast majority of which are problems of civilisation, prevention and access to care.

Nor will the European Central Bank, in the hands of former investment bankers, solve the ills of capitalism and the crises on the world's stock markets.

Nor will the prohibition of cash and its replacement by CBDC (Central Bank Digital Currency) bring transparency to criminal or unethical financial transactions.

Nor will the former European Coal and Steel Community solve our continent's energy problems.

Nor will the end of privacy - only for the general public - put an end to the terrorist threats to the global economy and our security.

Nor will the omnipresence of Artificial Intelligence and the abolition of the border between man and machine stop the decline in educational attainment and global intelligence.

On the contrary: the 'management' of the 'health crisis' was precisely the point at which a certain European policy was accelerated.

The European policy was first intended to bring progress and happiness to the West through economic liberalism.

Then, the European Union asked the people to adapt - at the cost of many sacrifices - to the World that its strategic choices had created in the most aware of the ways.

And today, the measures that are furthest removed from ecology, freedom, health, democracy and the right of peoples to self-determination are presented as the only way to save a Humanity that is in danger from those who want to impose them.

## Destruction, impoverishment and uglification of the World, attacks on human intelligence and heritage.

We are not going to pretend to be surprised by this development. We do know these choices were deliberately made to benefit a few supposed to deserve it because they consider to represent the most advanced Progress of the Reason in History or just a legitimate Anarcho-Capitalism or Social Darwinism.

But the destruction, impoverishment and uglification of the World, as well as the attacks on human intelligence and heritage in all their forms demonstrate every day the terrible blindness of these few.

For these reasons, we ask you to make the choice of Dignity, Freedom, Humanity and Future.

# IV- 2024 and the "International Agreement on Pandemic Prevention and Preparedness legally binding under international law"

2024 will be precisely the year in which Europe is due to sign an "international agreement on pandemic prevention and preparedness" with the World Health Organisation, "legally binding under international law" enabling to "ensure higher, sustained and long-term political engagement at the level of world leaders of states or governments; define clear processes and tasks; enhance long-term public and private-sector support at all levels; foster integration of health matters across all relevant policy areas." The official web page of the European Union adds: "early detection and prevention of pandemics, resilience to future pandemics, response to any future pandemics, in particular by ensuring universal and equitable access to medical solutions, such as vaccines, medicines and diagnostics, a stronger international health framework with the WHO as the coordinating authority on global health matters, the "One Health" approach, connecting the health of humans, animals and our planet." The pursuit of economic imperialism in the service of private interests in the tradition of "free trade" treaties and the modification of the definition of the term "pandemic" at the end of 2009

This agreement, scheduled for May 24, 2024, is in reality as opaque, useless and dangerous as the proposed Transatlantic Free Trade Agreement (TAFTA). It will authorise the WHO, to decide on the health policy of all the signatory countries, or of the European Union, simply by declaring a pandemic situation - even in the absence of a high mortality rate, by virtue of the change in the definition of the term "pandemic" in 2009. And all this with the immediate suspension of fundamental rights, under the pretext of a health emergency, the sharing of all medical data, the taking of a large part of national health budgets and the compulsory purchase of medicines or vaccines to be injected into the population to deal with the pandemic that the WHO will itself have declared. An announced social death for those who may refuse this diktat.

The WHO's operating costs are huge and out of all proportion to its usefulness. But there is much more: in 2017, a documentary by ARTE channel¹ revealed that on all theses issues, the WHO had lied, had remained silent or had seriously contradicted itself, harming populations for the benefits of private or States interests: managing epidemics and health crises - financing the pharmaceutical industry - the Bill & Melinda gates foundation and GAVI - Round-up and glyphosate in Argentina (malformations, handicaps, cancers, sterility...) - links with Monsanto GMOs - promotion of new dangerous drugs against tuberculosis (Bedaquiline, Delamanide...) - vaccines - H1N1 flu - Tamiflu - health studies - clientelism – violation of the precautionary principle – adverse events of medicines - environmental causes of disease - pollution (Nigeria) - unethical funding (tobacco, arms, alcohol) - links with Pfizer, Roche, Monsanto, Novartis, GlaxoSmithKline... - Accidents in Chernobyl and Fukushima - depleted uranium weapons (Iraq-Kosovo) - links with nuclear powers...

## World statistics of the adverse events and fatal outcomes of the mandatory vaccinations:

After the vaccinations, officially, 70,000 deaths and 11 million adverse events, of which nearly 3 million were serious adverse events, i.e. life-long disabilities, were reported: This is the lowest estimate of official international data for covid vaccines as of December 2020. These figures should be multiplied by 5 to 100 because of under-reporting due to medical and media denial of the victims. This means that covid vaccines may have caused more than 250 million serious adverse events and the deaths of 7 million people. A terrible, absurd and foretold price paid for experimental and ineffective vaccines, already obsolete due to the mutation of the virus and that, by the authorities' own admission, offered no protection against transmission. Given the inevitable allergies and the lack of prior testing, indiscriminate mass vaccination was bound to lead to countless serious and fatal accidents. Moreover, all the vaccines were produced and promoted by the most condemned international firms. They were administered even to the youngest children who were neither victims nor vectors of the virus, in violation of the precautionary principle and international conventions, and validated by scientific councils with multiple conflicts of interest.<sup>4</sup>

Let us remind that at no time since the spring of 2020 have the models of covid mortality produced by Neil Ferguson of Imperial College, who had already predicted the worst for H1N1, been approached or confirmed.

And yet, these announcements of millions of deaths and the misleading interpretation of PCR tests with amplification cycles that do not comply with the protocol, and in no way representative of any threat, enabled the governments to impose and provoke the worst. In reality, the risk of developing a severe form of covid affected only 0.05% of the population, and the average age of death was around 85 with co-morbidities.

#### VI - Historical and international texts and declarations (extracts)

#### The Hippocratic Oath (5th-4th century BC)

"I will follow that system of regimen which, according to my ability and judgment, I consider for the benefit of my patients, and abstain from whatever is deleterious and mischievous. I will give no deadly medicine to any one if asked, nor suggest any such counsel."

"Into whatever houses I enter, I will go into them for the benefit of the sick, and will abstain from every voluntary act of mischief and corruption (...). Whatever, in connection with my professional practice or not, in connection with it, I see or hear, in the life of men, which ought not to be spoken of abroad, I will not divulge, as reckoning that all such should be kept secret."

#### Modern version of the Hippocratic Oath (1964) for the USA

"I will apply, for the benefit of the sick, all measures [that] are required, avoiding those twin traps of overtreatment and therapeutic nihilism.

I will remember that there is art to medicine as well as science, and that warmth, sympathy, and understanding may outweigh the surgeon's knife or the chemist's drug.

I will not be ashamed to say "I know not", nor will I fail to call in my colleagues when the skills of another are needed for a patient's recovery.

I will respect the privacy of my patients, for their problems are not disclosed to me that the world may know. Most especially must I tread with care in matters of life and death. If it is given me to save a life, all thanks. But it may also be within my power to take a life; this awesome responsibility must be faced with great humbleness and awareness of my own frailty. Above all, I must not play at God. I will remember that I do not treat a fever chart, a cancerous growth, but a sick human being, whose illness may affect the person's family and economic stability. My responsibility includes these related problems, if I am to care adequately for the sick.

*I* will prevent disease whenever *I* can, for prevention is preferable to cure."

#### The Nuremberg Code, 1947

- 1 "The voluntary consent of the human subject is absolutely essential. This means that the person involved should have legal capacity to give consent; should be so situated as to be able to exercise free power of choice, without the intervention of any element of force, fraud, deceit, duress, overreaching, or other ulterior form of constraint or coercion; and should have sufficient knowledge and comprehension of the elements of the subject matter involved as to enable him to make an understanding and enlightened decision. This latter element requires that before the acceptance of an affirmative decision by the experimental subject there should be made known to him the nature, duration, and purpose of the experiment; the method and means by which it is to be conducted; all inconveniences and hazards reasonably to be expected; and the effects upon his health or person which may possibly come from his participation in the experiment. The duty and responsibility for ascertaining the quality of the consent rests upon each individual who initiates, directs, or engages in the experiment. It is a personal duty and responsibility which may not be delegated to another with impunity.
- 2- The experiment should be such as to yield fruitful results for the good of society, unprocurable by other methods or means of study, and not random and unnecessary in nature."

#### International Munich Declaration of the Duties and Rights of Journalists (1971)

"Never confuse the profession of journalist with that of advertiser or propagandist; accept no instructions, direct or indirect, from advertisers"

#### The Oviedo Convention on Human Rights and Biomedicine (1997)<sup>5</sup>

"Concerning interventions on the human genome, they may only be undertaken for preventive, diagnostic and therapeutic purposes and only if they do not result in any modification in the genome of the descendants (article 13)."

#### The Precautionary Principle

"The precautionary principle allows decision-makers to adopt precautionary measures when the scientific evidence concerning a risk to the environment or human health is uncertain and the stakes are high. It first appeared in the 1970s and has since been enshrined in a number of international environmental treaties, in the Treaty on the Functioning of the European Union and in the national legislation of some Member States."

## Code of Conduct for Members of the European Parliament with respect to financial interests and conflicts of interest

"In exercising their duties, Members of the European Parliament:

(a) are guided by and observe the following general principles of conduct: disinterest, integrity, openness, diligence, honesty, accountability and respect for Parliament's reputation, (b) act solely in the public interest " *Article 1*, *Guiding principles*

#### VII - A Humanist, Ethical and Medical Charter for the 2024 European Elections

The previous pages did nothing but remembering recent and historical facts and declarations.

As such, in view of the indisputably catastrophic record of the past four years, due by common knowledge to private interests devoid of consideration for the Common Good, and the threats that continue to hang over the health, democracy, freedom and fundamental rights of populations in the coming year, will you bring your support through words, deeds and legislation to the following Humanist, Ethical and Medical Charter? Will you stand with us for our Humanity?

#### Health, freedom, vaccines and the precautionary principle

- the withdrawal from the market of experimental anti-covid mRNA vaccines that have been shown to be ineffective and dangerous by the very admission of the manufacturers and the authorities;
- the abandonment of compulsory vaccination, particularly for children, as a condition of access to healthcare, education, leisure and basic health services;
- the recognition of the adverse events of vaccines and the introduction of care and financial and moral compensation;
- the introduction of large-scale, active, simple and remunerated pharmacovigilance of vaccinations, carried out by bodies and associations that are independent of pharmaceutical companies and political powers;
- an end to the pharmaceutical companies "irresponsibility clause" regarding the adverse events of vaccinations;
- an end to mass vaccination during epidemics;
- the withdrawal of the recent imposed vaccines without valid reason and a priority committee of enquiry into the links between vaccinations and childhood autism;
- the immediate withdrawal of Beyfortus, which is not a vaccine but a drug, more precisely a monoclonal antibody in the form of an injectable solution against bronchiolitis, the effectiveness of which has been called into question and which has already caused the death of many infants;
- the transparency on the effectiveness of current treatments and links to the pharmaceutical industry.
- the withdrawal of the project of the WHO "international agreement on pandemic prevention and preparedness", scheduled for 24 May 2024;
- the transparency on the WHO funding from tax-evading foundations that do not respect the environment and human rights;
- a return to the pre-May 2009 definition of the term "pandemic" in relation to the real, large-scale threat to people's health;
- the refusal of the transfer of medical data at global level provided for in the WHO treaty on pandemics;

- compliance with the Nuremberg Protocol on free, informed and enlightened consent;
- compliance with the Oviedo Convention on the non-experimentation of human beings;
- reinstatement of medicines and treatments banned since the pandemic for private economic interests;
- authorisation and reimbursement of the traditional and natural medicines that prooved their efficiency;
- the evaluation by an independent commission of the European Union's response to the covid 19 crisis:

#### **Autism**

- the establishment of an independent commission of enquiry on the direct relationship between vaccines and the alarming rise in children autism<sup>7</sup>

#### **Endocrine disruptors**

- an investigation followed by decisions on the damage caused by endocrine disruptors;

#### **Technology and environment**

- a halt to the proliferation of 5G antennas and the tree cuttings linked to it. The negative effects of 5G antennas, particularly carcinogenic, have already been proven and an independent commission of enquiry should also be dedicated to them;
- a halt to massive investment in electronic components, leading to large-scale consumption and pollution of water reserves.
- taxing paraffin, in line with declarations on fossil fuels and their impact on the environment.
- The imposition of more stringent rules on States concerning electromagnetic pollution and the recognition of hypersensitivity;

#### Children and education:

- the protection of children against any instrumentalisation or experimentation for economic or ideological ends, considering the mistakes and lessons of the past in education and media violence;
- an assessment of the psychological and physical consequences of widespread sex education and gender theory on children (early transition, puberty blockers, etc.) and a public debate on the subject;
- the protection of the freedom to homeschool in all countries of EU

#### Agriculture, food and animal cause:

- subsidising a farmland that protects the environment and public health;
- a ban on glyphosate consistent with that on Round Up;
- an end to imports of environmentally destructive agricultural products
- animal welfare at all stages as an absolute rule of farming;

#### Media and culture

- the abolition of media censorship on questions of public interest and protection;
- the application of the Munich Charter (1972) concerning the independence, rights and duties of journalists;
- the prohibition of violent programmes that degrade the Human person;

#### **Democracy**

- the respect for the founding principles of the European Union after the Second World War: Peace, Democracy and Progress
- the right of people to self-determination and respect for their will;
- a halt to the process of the disappearance of states within the European Union;

#### War in Ukraine, Conflicts and International security:

- giving priority to diplomatic solutions and the right of peoples to decide for themselves;
- an end to the supply of arms to countries that do not respect human rights;

#### **Economy**

- a halt to the process of the disappearance of cash and its replacement by CBDC (Central Bank Digital Currency);
- the cooperation between the different political groups on issues of general interest, regardless of ideological differences or pressure from EU lobbies and private interests;

#### **Lobbies and Conflicts of interest:**

- the publication, cessation and judgement of all conflicts of interest, especially between members of the European Union and the pharmaceutical industry;
- a ban on lobbies promoting interests contrary to health, democracy, the environment, education, personal freedom or security;

#### **Nuclear Energy**

- the resignation of the agreement of the WHO with the International Atomic Energy Agency (IAEA), referred to as "WHA12-40"(1959) and the transparency on the consequences of the use of nuclear energy on the populations.
